XC Course Walk: Course will be open after 3:00 p.m. the day before the event.

Awards: First through eighth place awarded in each division.
End-Of-Series Award: Given to the best average score from two 2012 FFHT's of the same horse/rider combo, however scores can be from different divisions. A 3-point advantage will be given to same horse/rider combos who attend all 3 events.
